### **Position Summary**

---

Global Water 2020 is a three-year advocacy and facilitation initiative designed to accelerate progress toward water access and security for all people in developing countries. Non-partisan and fully-funded, we are a catalyst working behind the scenes to increase U.S. and global public and private responses to a limited number of critical, under-resourced international water challenges.

Global Water 2020 is seeking a full-time intern (preferably 2<sup>nd</sup> year Master's student or recent graduate) to assist with a wide range of projects that support our advocacy, communications, facilitation and research efforts, including those related to the UN Secretary-General's Call to Action for WASH (Water, Sanitation, and Hygiene) in healthcare facilities, neglected tropical diseases (NTDs), cholera and hydro-diplomacy. Global Water 2020 interns will support the Global Water 2020 team and report to the Senior Associate.

The intern will primarily work on projects relating to WASH in healthcare facilities. These include, but are not limited to, helping plan various local, regional and global convenings; supporting activities around the Year of the Nurse and Midwife; and assisting in the development of an online course, among other activities. Other priority projects will include supporting the communication and advocacy efforts of the NTD NGO Network's WASH Working Group, conducting research on key stakeholders and platforms, and overseeing social media activity.

- Research U.S.-based and international non-profit, private sector and educational institutions working on global WASH, health and peace efforts
- Develop and update inventory of global WASH, health and peace funders
- Brainstorm and help identify domestic, regional and global collaboration opportunities
- Help write, edit, and format materials for stakeholder meetings
- Track global and regional convenings and assist in prioritizing which events Global Water 2020 should influence
- Maintain Global Water 2020's social media presence, and support social media campaigns for global awareness days and key events
- Assist Global Water 2020 team in all other duties as assigned

The intern will have strong time management, multitasking, research and writing skills, as well as a positive attitude, willingness to learn and good sense of humor.

Our internships run during the summer or school semester. We expect forty hours per week during the Spring 2020 term. This internship will be compensated at \$15.00 per hour. You must be eligible to work or intern in the U.S. The Global Water 2020 office is located in the DuPont Circle area of Washington DC.
