 WSSCC Civil Society Strengthening, Accountability and Voice Grants for Togo, Uganda, Cambodia and Madagascar The grant focuses on ensuring that the voice of people in vulnerable situations is heard in policy

dialogue and debates on sanitation, hygiene and menstrual health and hygiene (MHH). DEADLINE: Sunday (10 May 2020)

Government of Canada's COVID-19 Rapid Research Funding Opportunity

These grants are for research on health and COVID-19. Areas of study include infection prevention and control measures and public health communications and citizen engagement. See list of specific eligibility requirements.

The Lion's Share - COVID-19 Response Resilience in Wildlife Community Small Grants

Grants are available for COVID-19 response initiatives conducted in wildlife rich areas (prone to wildlife-based tourism) in developing countries - these initiatives should demonstrate innovative local-level action to increase resilience and well-being of communities against external shocks such as pandemic crises. DEADLINE: next Friday (15 May 2020)

Islamic Development Bank Group's Transform Fund 2020 The Transform Fund 2020 is supporting proposals for long-term solutions to COVID-19 in IsDB member countries.
